- **a.** A comparative Appraisal of the System of Customary Arbitration in Modern Times: A Case Study of Nigeria and Ghana
- This research is interested in identifying the roots and importance of customary arbitration in Africa using Nigeria and Ghana as case study. The research is to discover the continued difficulties and uncertainties which customary arbitration as a concept is facing and will continue to face if the issue is not carefully addressed. The research will also argue that although customary arbitration has its flaws, it will be illogical to leave the concept as it is or to disallow judicial activism to bring the concept back to life. Furthermore, the research will emphasise the legal relevance and juristic value of customary arbitration and the need to protect customary arbitration from extinction. Finally, the main objective of this research is to forge a workable national dispute resolution system that respects both the rule of law and traditional social norms.
